We would like to thank you for participating in this process and for your valued comments.</p> <p>We confirm that your response will be added to the final BAR and/or EMPr, but wish to respond directly as follows:</p> <p>Ad paragraph 1</p> <p><i>“Public participation (PP) undertaken for the project is not adequate. Please note “you are required to contact department of economic, small business development, tourism and environmental affairs” and please note that a note board must be written at least with two official languages.”</i></p> <p>Greenmined takes note of your request that the Department of Economic, Small Business Development, Tourism and Environmental Affairs (DESBTEA) must be informed of the project. Although the proposed mining area does not extend into the Free State Province, the DESBTEA will be informed of the project and afforded an opportunity to comment on the DBAR & EMPr.</p> <p>During the initial public participation process two English notice boards were placed to inform the general public of the proposed activity. The community of Aliwal North is well versed in English and it was therefore not deemed necessary to display the on-site notices in two languages. Chapter 6 of the EIA Regulations also does not require the on-site notice to be in “<i>at least two official languages</i>”, In light of this, we respectfully request you to consider this request.
