CONFIRMATION OF A GENERAL AUTHORIATION IN TERMS OF SECTION 39 OF THE NATIONAL WATER ACT, 1998 (ACT 36 OF 1998) ON PORTION 7 OF THE FARM ROODEKRANS 457 IT: ROODEKRANS QUARRY

Reference is made to the documentation dated November 2013 and the updated master plan layout dated 10 July 2015.

The Department has evaluated the above-mentioned documentation, and based on the evaluation it was confirmed that this water use activity falls within the ambit of a general authorisation. The ecological risk that might be posed by the activity is low. Therefore, this letter confirms that the water uses, Section 21(c) and (i) are authorised in terms of General Authorizations No. 1199 dated 07 December 2009 under Section 39 of the National Water Act, 1998 (Act 36 of 1998) (NWA).

Your attention is further drawn to the following:

- 1. This General Authorisation authorizes the gravel mining on portion 7 of the farm Roodekrans 457 IT;
- 2. The water user shall ensure that the water use activity does not impact on other water users, property or land;
- 3. The water user shall rehabilitate the affected areas after completion of the activities; and
- 4. The water user shall not be construed as being exempted from compliance with the other legislations, Regulations or By-laws.

Please note that failure to comply with the conditions of the General Authorisation your water use will be regarded as unlawful. You may subsequently be required to apply for a water use licence in terms of (NWA), however the issuance of such a licence cannot be guaranteed.
