### **DETAIL OF PROPOSED DEVELOPMENT**

Provide a full description of the nature and extent of the proposed development.

The Applicant, CZ Sand Mine (Pty) Ltd, is applying for environmental authorisation (EA) and a mining permit to mine sand on a portion of the remaining portion of the Farm Rhenosterkop no 155, Registration Division of Beaufort West, Western Cape province.

The proposed mining area is approximately 5 ha in extent and will be developed over an undisturbed and inactive area of the farm. The applicant, intends to obtain material from the area for at least 2 years with a possible 3-year extension. The proposed sand mine will appoint ±6 employees, and due to the small scale of the operation no infrastructure, other than a chemical toilet, must be established within the mining footprint. The proposed mining area will be reached via an existing farm road that will be upgraded and maintained for the duration of the operational phase.

The sand extracted from the sand mine will be used for the construction industry in the surrounding area. The proposed sand mine will contribute to the upgrading / maintenance of road infrastructure, renewable energy projects and building contracts in and around the Beaufort West area.

The proposed operation is representative of the small-scale mining industry where the mineral (sand) is loaded with a Front-End-Loader (FEL) directly from the mining footprint area to the stockpile area, following standard practices in the small-scale mining sector. If necessary, the sand will be screened before being stockpiled. Once ready for distribution, a front-end loader will load the sand onto trucks for delivery to customers. No washing of sand will be required. All mining related activities will be contained within the limits of the authorized mining permit.

The proposed project triggers listed activities in terms of the National Environmental Management Act, 1998 (Act 107 of 1998) and the Environmental Impact Assessment Regulations 2014 (as amended 2017) and therefore requires an environmental impact assessment (Basic Assessment process) that assesses project specific environmental impacts and alternatives, considers public input, and proposes mitigation measures, to ultimately culminate in an environmental management programme that informs the competent authority (Department of Mineral Resources and Energy) when considering the environmental authorisation.

A few CRM surveys have occurred in the vicinity. To the north of the N1 a quarry access road was surveyed and revealed MSA artefacts and, along the edge of the dolerite scarp targeted for mining, historical rock engravings (Orton 2010; the quarry itself has apparently been surveyed and permitted but no documentation of this is known and none could be sourced from the developer at the time of the road application). This project included the widening of the N1 through Courlandskloof and in other areas a variety of finds was seen, including artefacts from the Early, Middle and Late Stone Ages, as well as historical artefacts (Orton 2010). A further quarry site immediately north of the above-mentioned quarry revealed a stone-walled kraal (Gribble 2020). Orton (2023) looked at a quarry site just east of the present study area and found only ephemeral traces of engraving in the form of scratches on the dolerite. However, elsewhere on the farm the land owner indicated fine line engravings of eland and other animals. An elephant engraving apparently also occurs in the area but could not be found at the



time of that visit. Around Nelspoort, to the northeast of the study area, there are a number of rock engravings and some rock gongs that are quite well-known (Parkington *et al.* 2008).

Historical structures, artefacts scatters and aspects of the historical nineteenth century Cape Town to Kimberley railway (which broadly follows the N1) were also recorded by Orton (2010). The latter include a cast iron and stone bridge and also an Anglo-Boer War blockhouse built at the bridge to guard it during the war.

More broadly, most Karoo farms include historical structures and graves and the kinds of archaeology noted above are expected to be widespread. Rock paintings are also known from the Karoo, but not from anywhere close to the study area.

Survey diagrams indicate that Rhenosterkop was first granted on 18 November 1890 to Adolph Siegfried Grimbeek. Portions referred to as Lucerne Lodge and Annex Lucerne Lodge were subdivided off on the northwest side of the railway line during the early 20<sup>th</sup> century. Various other subdivisions have also occurred for the railway on the land to its northwest. The rest of the farm to the south of the railway line, however, has remained intact.

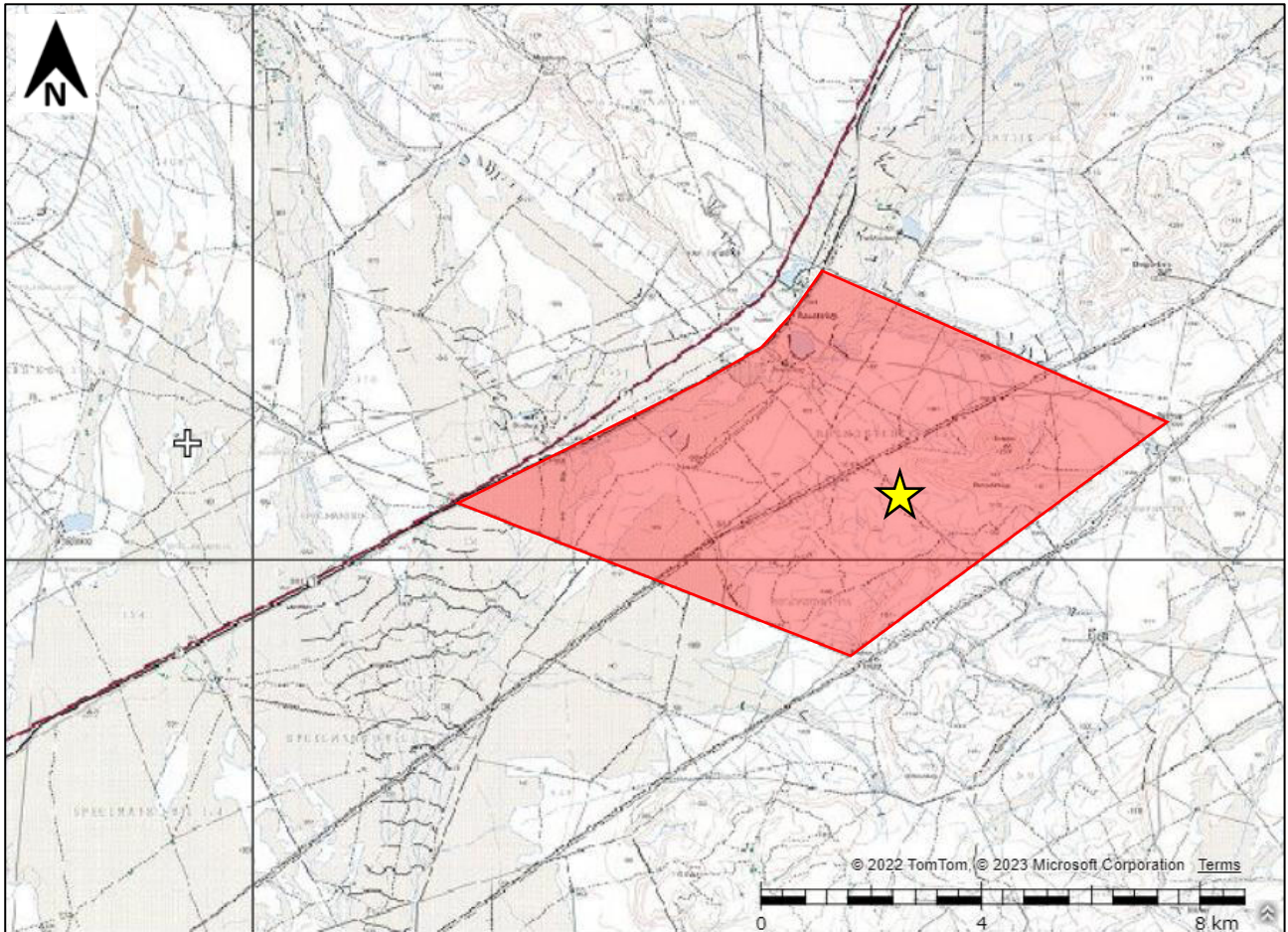

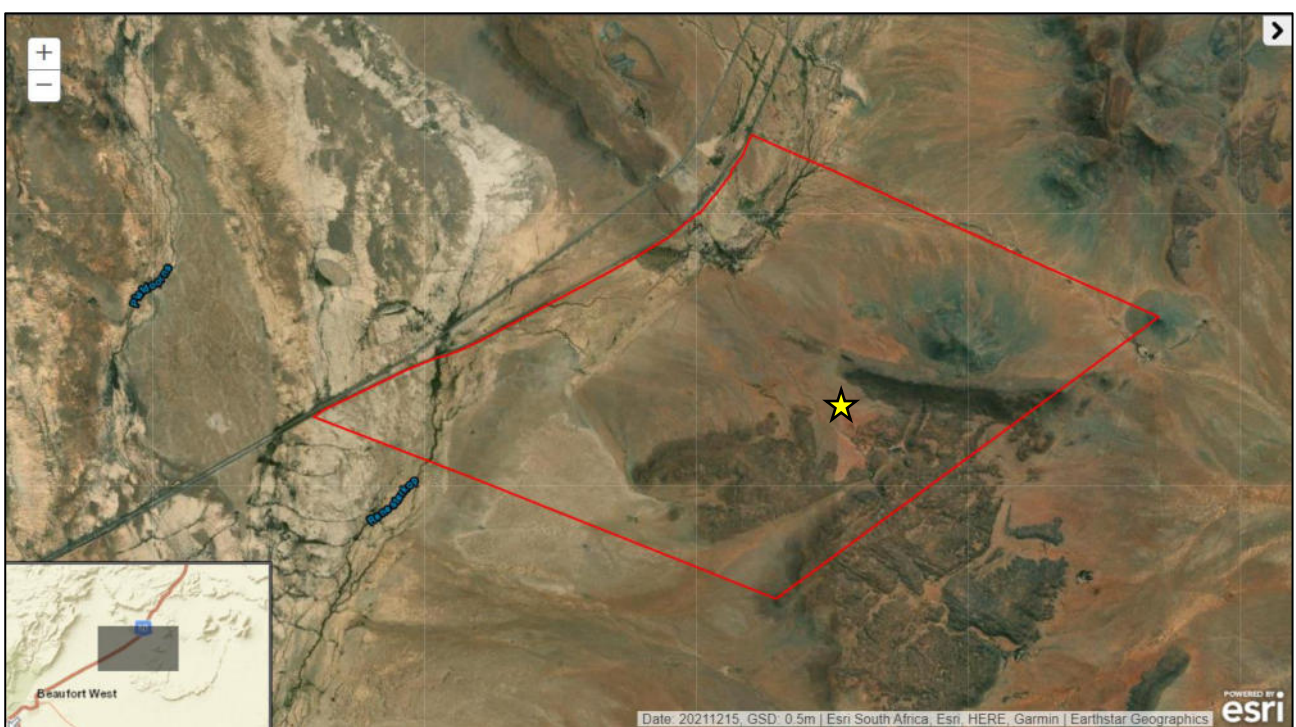

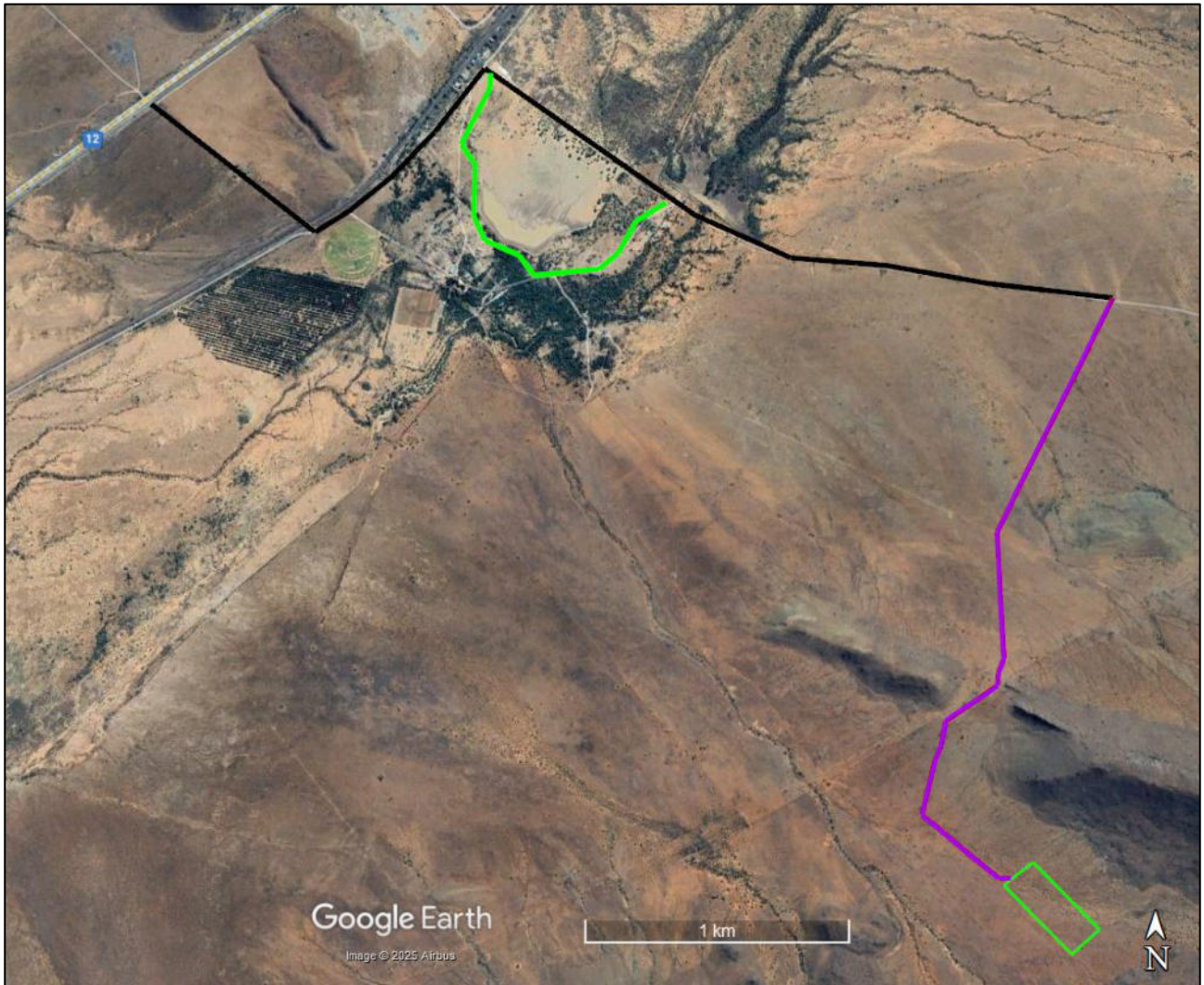


Extract from 1:50 000 mapsheet 3222BA showing the location of the property (red shaded polygon) and study area (yellow star).

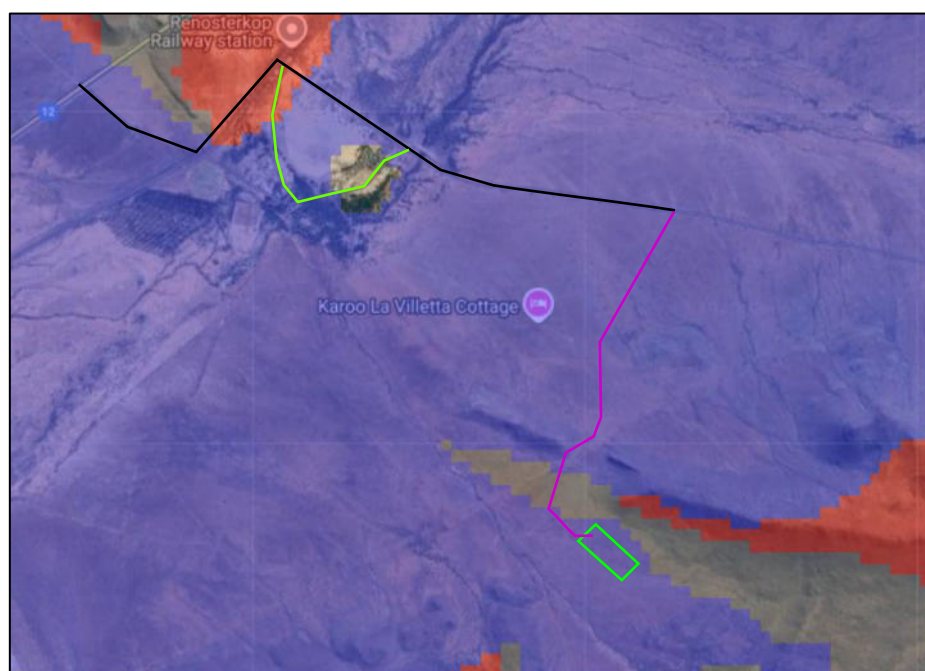


Aerial view showing the farm boundary (red polygon) and location of the study area (yellow star).



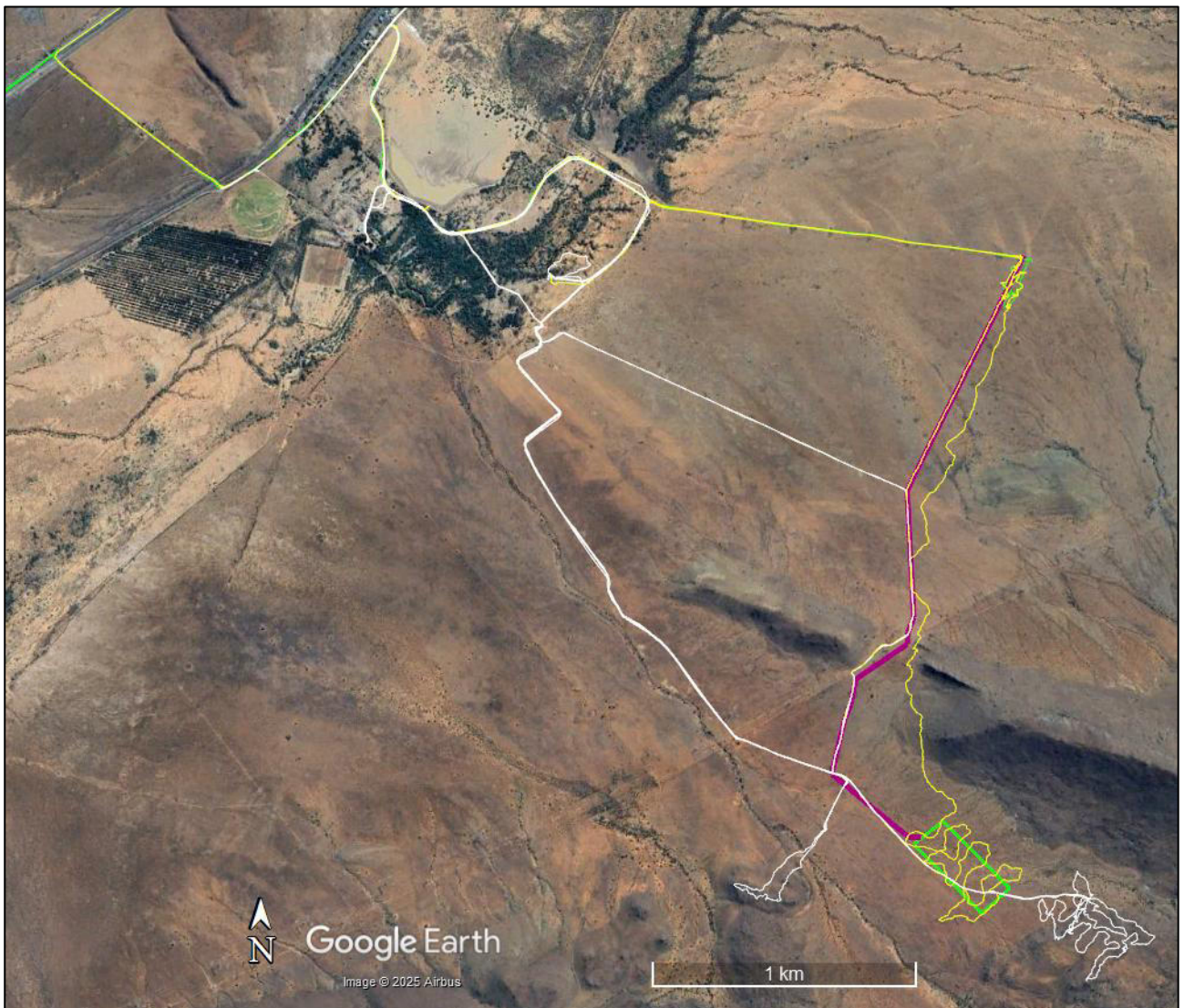

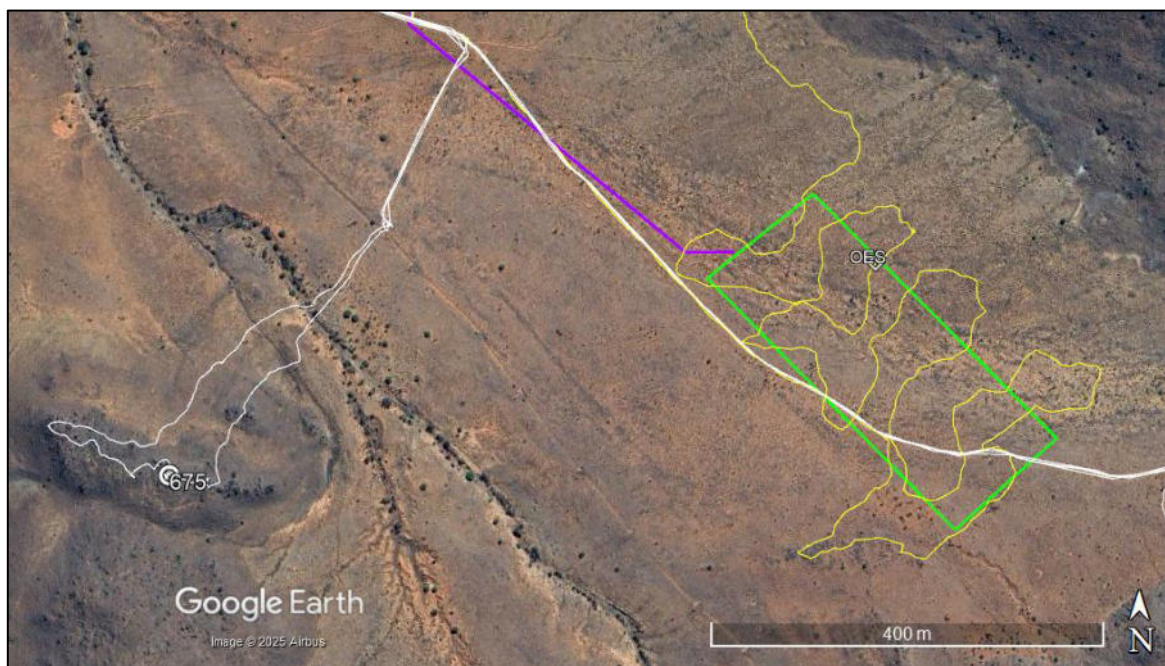


Extract from the SAHRIS Palaeosensitivity map showing the study area to be of low palaeontological sensitivity (blue shading). Key as per above.



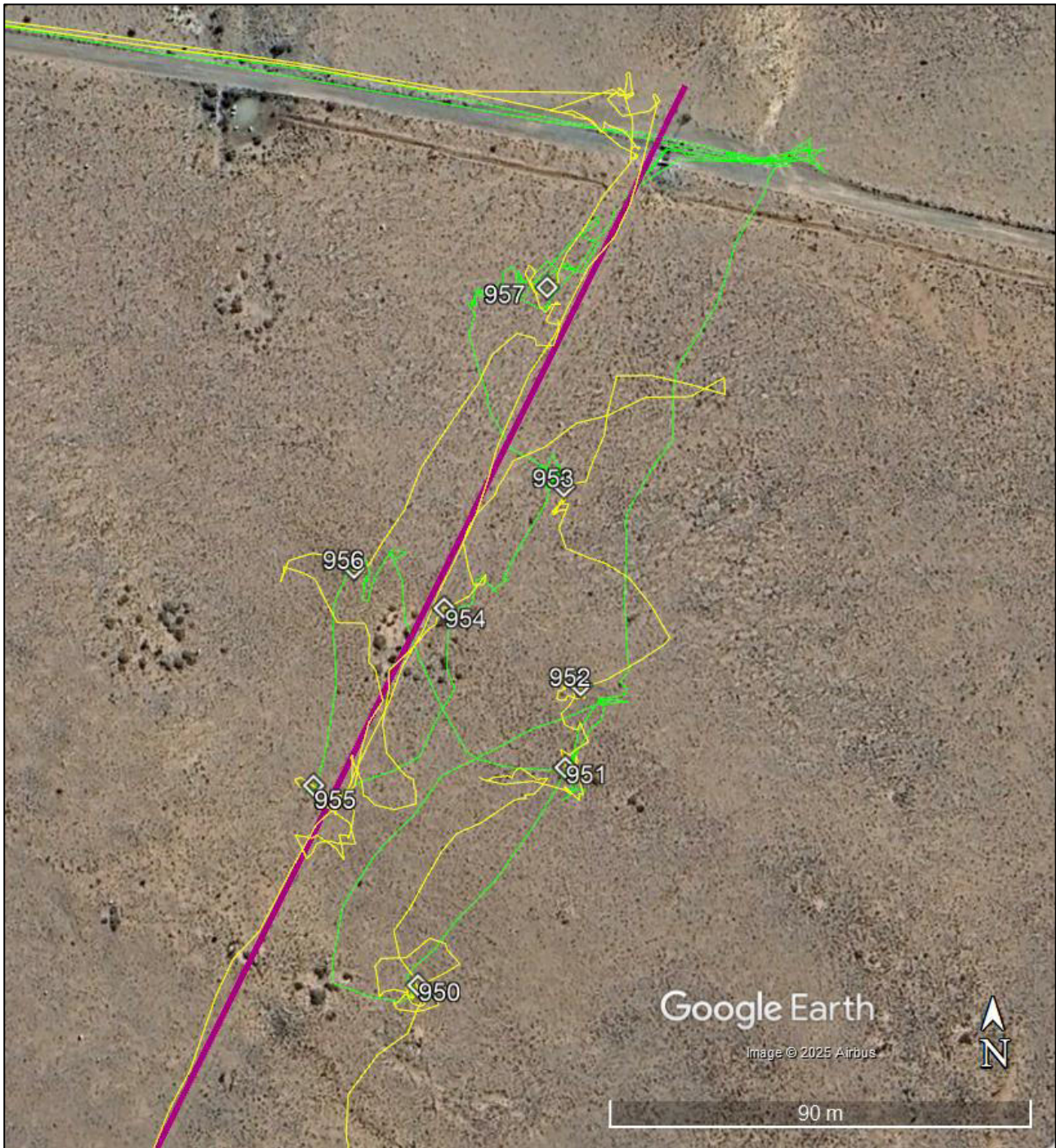


Survey tracks (white lines = Jayson Orton 2023, yellow lines = Jayson Orton 2025, green lines = Madelon Tusenius 2025).



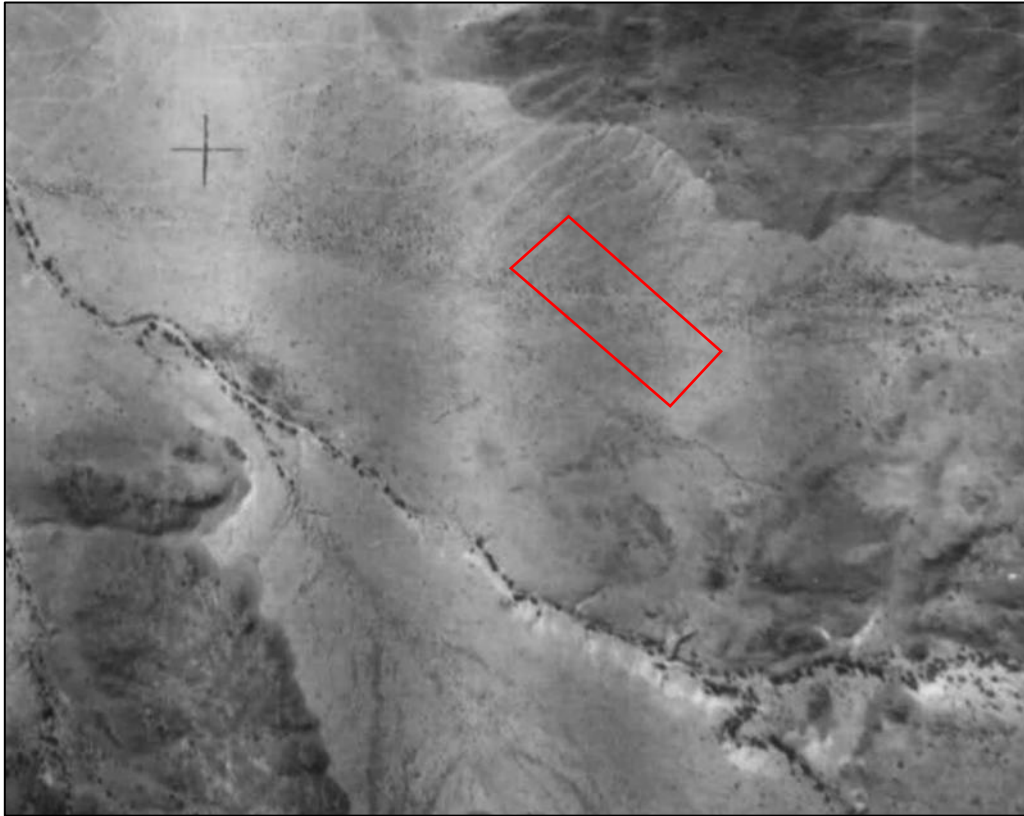


Close up of the southern part of the study area showing the location of a single ostrich eggshell fragment (OES).
