**Background Information**

Jan Jacob De Clercq Van Zyl, currently holds a Mining Permit (NC 30/5/1/3/2/10489 MP) and approved Environmental Management Programme (EMPr) over A portion of Portion 1 of the Farm Koenabib, No 43, Khai Ma Local Municipality, Namakwa District Municipality, Namaqualand Magisterial District, Northern Cape Province. Jan Jacob De Clercq Van Zyl, intends to apply for a mining permit amendment, to extent the area from 1.3544ha to 5ha and the addition of the mineral aggregate, stone gravel, in terms of Section 102 of the MPRDA, 2002.

The area earmarked for the proposed mining falls on a section of the farm that was previously used for sillimanite, re-mining and the intention of this application is to increase the existing operation and to addition of aggregate and stone gravel. The material is loaded from the existing stockpiles (old mine dumps) and hauled to the mobile crushing and screening plants. The sillimanite, aggregate stone gravel will be screened to various sized stockpiled. The sillimanite, aggregate stone gravel will be stockpiled and transported to clients via trucks and trailers. All activities will be contained within the boundaries of the site.

**Legal Compliance**

**Amendments to be applied for in terms of Part 2**

33. (1) The competent authority must within 107 days of receipt of the report contemplated in regulation 32, in writing, decide the application;  
(2) On having reached a decision, the competent authority must comply with regulation 4(1), after which the holder applicant must comply with regulation 4(2).

Other legislation triggered by the proposed project includes:

- An amendment of the Mining Right Application in terms of Section 102 of the Mineral and Petroleum Resources Development Act, 2002 (Act No. 28 of 2002) has been submitted to the Department of Mineral Resources.

Interested and Affected Parties (I&AP's) are invited to provide written comments. I&AP's must provide their comments with their name and contact details to the environmental consultant indicated below within 30 days from the date of this notice (22 November 2019 - 14 January 2020).
