In light of this, the stakeholders and I&AP's were informed, of the S102 amendment application and proposed extension of the drill plan, by means of a notification letter that invited comments on the DBAR and draft EMPR, on-site notices and an advertisement in the Northern Cape Express. A 30-day commenting period from 29 January to 02 March 2020 was allowed.
