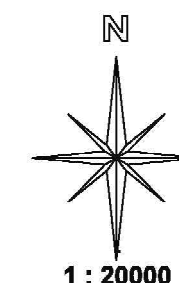

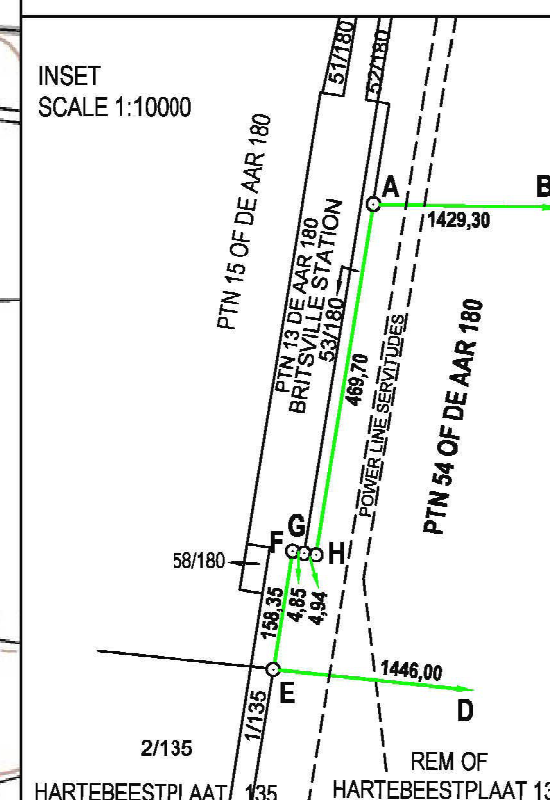

We refer to your letter received: **23 May 2025.**

We confirm that as at the date of this letter that no land claim appears on our database in respect of the Properties this includes the database for claims lodged by 31 December 1998; and those lodged between 1 July 2014 and 27 July 2016 in terms of the Restitution of Land Rights Amendment Act, 2014.

Whilst the Commission takes reasonable care to ensure the accuracy of the information it provides, there are various factors that are beyond the Commission's control, particularly relating to claims that have lodged but not yet been gazetted such as:

- Some Claimants referred to properties they claim dispossession of rights in land against using historical property descriptions which may not match the current property description; and
- Some Claimants provided the geographic descriptions of the land they claim without mentioning the particular actual property description they claim dispossession of rights in land against.

The Commission therefore does not accept any liability whatsoever if through the process of further investigation of claims it is found that there is in fact a land claim in respect of the above property.

If you are aware of any change in the description of the above property after 19 June 1913 kindly supply us with such description so as to enable us to do a further search.

APPLICATION FOR A NEW PLANT STANDARD APPLICATION FOR A NEW PLANT STANDARD FOR PARTICULATE MATTER FOR THE SOUTH32 MAMATWAN HOTAZEL MANGANESE MINE SINTER PLANT WASTE STACK

Notice is hereby given in terms of Section 12A of the Amendments to the Listed Activities and Associated Minimum Emission Standards Identified in terms of Section 21 of the National Environment Management: Air Quality Act, 2004 (Act No. 39 of 2004) (NEM:AQA; GNR. 1207 of 2018) that South32 Mamatwan Hotazel Manganese Mine (South32 MMT) intends to apply for a new plant standard for the Sinter Plant Waste Stack for Particulate Matter (PM) only.

LEGAL FRAMEWORK: In terms of the NEM:AQA, Sinter Plants are required to meet the Minimum Emission Standards (MES) contained in GNR 893 that was issued on 22 November 2013 (as amended by GNR 1207 on 31 October 2018) and promulgated in terms of Section 21 of the NEM:AQA. This application is linked to the PM emissions associated with activities promulgated in terms of Section 21 of the NEM:AQA GNR 893 (22 November 2013), as amended:

- Subcategory 4.5: Sinter Plants.

Section 12A of the NEM:AQA Listed Activities (GNR. 1207) grants an existing plant the right to apply for a new plant standard providing that the plant is in compliance with other emission standards but cannot comply with a particular pollutant or pollutants. The Sinter Plant Waste Stack currently complies with the MES for new plants for Sulphur Dioxide (SO₂) and Nitrogen Dioxide (NO₂); however, PM is non-compliant. The Section 12A application is required to allow South32 MMT reasonable time to complete the installation of a new Electrostatic Precipitator (ESP) for the Sinter Plant Waste Stack, which once installed and operational by April 2029, will enable the Sinter Plant Waste Stack to comply with the MES for PM for new plants (50 mg/Nm³). The Section 12A application is made with due consideration of the air quality surrounding South32 MMT.

REGISTRATION: South32 MMT has appointed WSP Group Africa (Pty) Ltd (WSP), as an independent service provider, to conduct the Section 12A application, which includes an Atmospheric Impact Report. 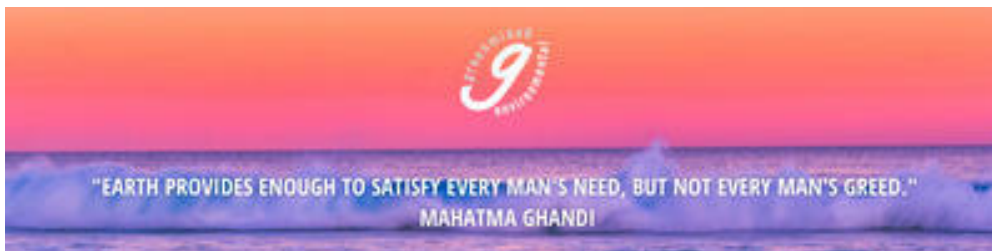
