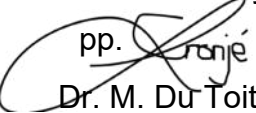
1. Some Claimants referred to properties they claim dispossession of rights in land against using historical property descriptions which may not match the current property description; and

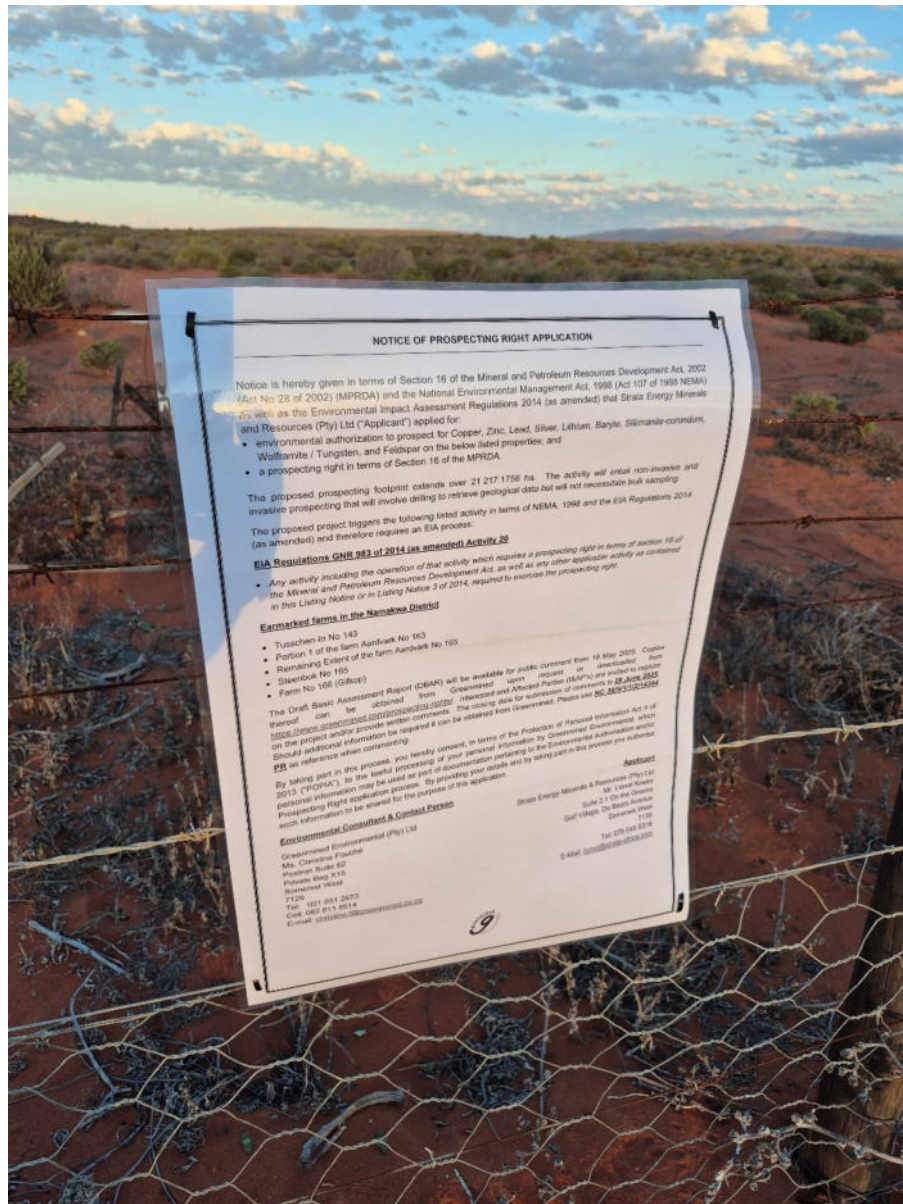
