## **I&AP COMMENTS AND RESPONSE REPORT OF THE PUBLIC PARTICIPATION PROCESS FOR THE SECTION 24G APPLICATION**

*COMMENTING PERIOD: 10 MARCH 2026 – 15 APRIL 2026*

The relevant surrounding landowners, and I&AP's were informed of the Section 24G application by means of an advertisement in the BloemNuus newspaper, and on-site notices that were placed at the entrance gate of Farm Chez Nous, and at the public notice board at fuel station Tom's Place.

A notification letter inviting comments on the Draft Basic Assessment Report over a 30-day commenting period was sent to the neighbouring landowners, and other I&AP that may be interested in the project. Also refer to Appendix E2 for the Proof of Public Participation that was conducted.

The following figure shows the farm Chez Nous No 1775 in relation to the surrounding properties. As evident in this image, all the surrounding properties with the exception of the farms Lions Hill are owned by Bachrust Dairy (Pty) Ltd.

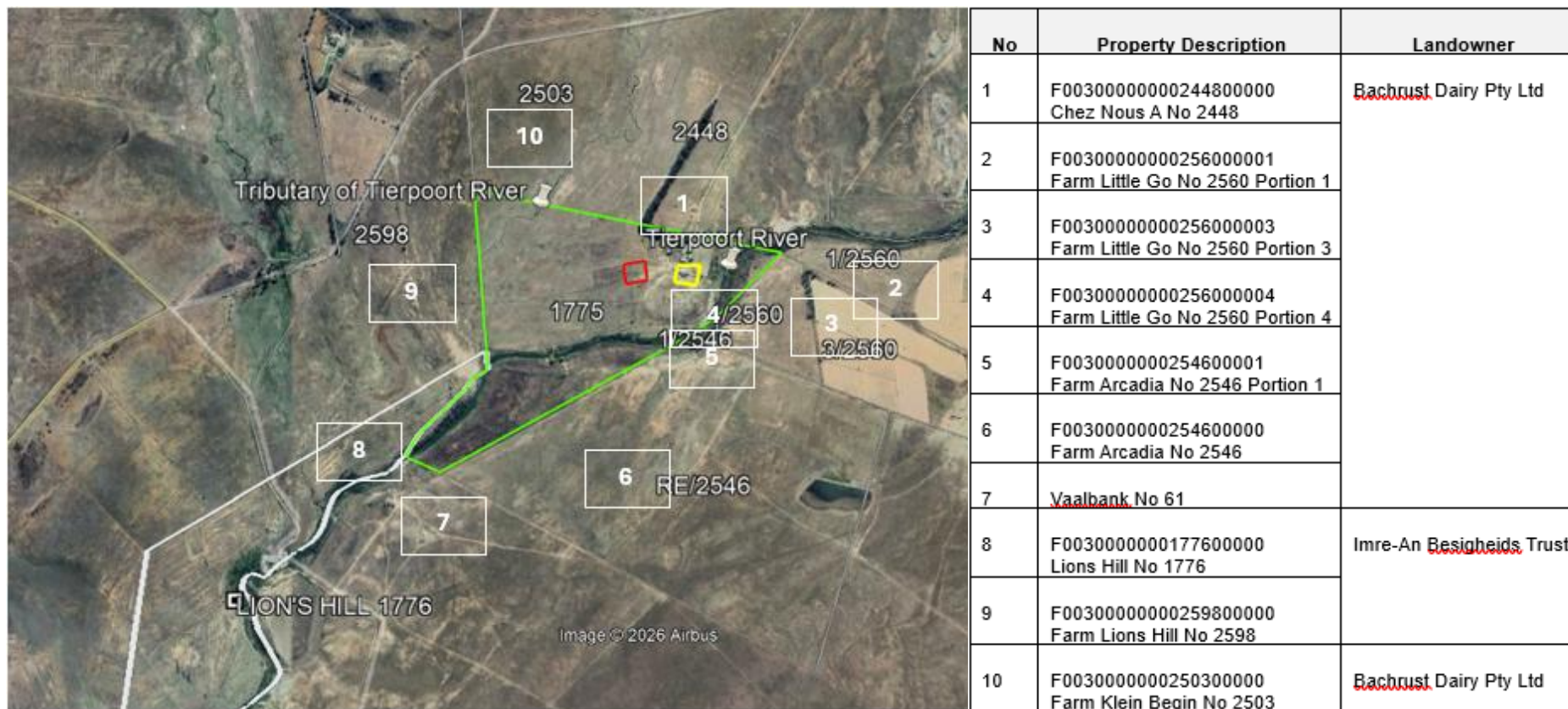


Figure 1: Chez Nous No 1775 in relation to the surrounding properties.
