



- 1.1. The consultation letter dated June 2022 with reference no: FS30/5/1/2/2/10071MR is here by referred to:
- 1.2. Section 21(i) of the National Water Act, 1998 (Act 36 of 1998) (NWA) defines altering the bed, banks or characteristics of a watercourse as a water use.
- 1.3. In terms of Section 22 of the NWA a person may only use water without a license:
 - 1.3.1. If that water use is permissible under Schedule 1.
 - 1.3.2. If that water use is permissible as a continuation of an existing lawful use.
 - 1.3.3. If that water use is permissible in terms of a General Authorisation issued under Section 39 of the NWA.
- 1.4. In terms of Section 4(1) of the NWA a person may use water from a water resource for purposes such as reasonable domestic use, domestic gardening, animal watering, fire fighting and recreational use, as set out in Schedule 1.

- 1.5. An existing lawful water use is defined, in terms of Section 32 of the NWA, as a water use:
 - 1.5.1. Which has taken place at any time during a period of two years immediately before the date of commencement of the NWA. [1 October 1998 for groundwater uses and 1 October 1999 for surface water uses.]
 - 1.5.2. Which was authorised by or under any law which was in force immediately before the date of commencement of the NWA.
 - 1.5.3. Which is a stream flow reduction activity contemplated in Section 36(1) of the NWA.
 - 1.5.4. Which is a controlled activity contemplated in section 37(1) of the NWA.
 - 1.5.5. Which has been declared an existing lawful water use under Section 33 of the NWA.
- 1.6. Government Notice No. 398 (GN398) of 26 March 2004 (Gazette No. 26187) General Authorisations in terms of Section 39 of the NWA and determines that water uses are permitted in areas where general authorisations are applicable provided that the uses are within the limits and conditions set out in the General Authorisation.
 - 1.6.1. Paragraph 2.7.(1) of GN398 determines, inter alia, that a person who owns or lawfully occupies property registered at the Deeds Office at the date of the Notice or lawfully has access to land on which the use of water takes place may:
 - (i) On that property or land alter the bed, banks or characteristics of a watercourse if the alteration;
 - (aa) does not impact on a water resource or any other person's water use, property or land;
 - (bb) is not detrimental to the health and safety of the public in the vicinity of the activity.
 - (ii) the natural migration patterns of aquatic biota and the sustainable ecological functioning of the system are not interfered with.
 - (iii) the alteration activity does not extent for more than 50 meters continuously or a cumulative distance of 100 metres on that property or land, measured along the watercourse
 - (iv) the volume of flow is not reduced except for natural evaporative losses
 - (v) strict erosion control measures are to be taken during and after construction to ensure no erosion of the bed and banks of the river takes place
 - (vi) the water quality is not detrimentally affected
 - (vii) all necessary measures are taken to stabilize the structure and surrounding area.



NATIONAL WATER ACT, 1998 (ACT 36 OF 1998)

Schedule 1

PERMISSIBLE USE OF WATER

[Sections 4(1) and 22(1)(a)(i) and Item 2 of
Schedule 3]

- (1) A person may, subject to this Act -
 - (a) take water for reasonable domestic use in that person's household, directly from any water resource to which that person has lawful access;
 - (b) take water for use on land owned or occupied by that person, for -
 - (i) reasonable domestic use;
 - (ii) small gardening not for commercial purposes; and
 - (iii) the watering of animals (excluding feedlots) which graze on that land within the grazing capacity of that land, from any water resource which is situated on or forms a boundary of that land, if the use is not excessive in relation to the capacity of the water resource and the needs of other users;
 - (c) store and use run-off water from a roof;
 - (d) in emergency situations, take water from any water resource for human consumption or fire fighting;
 - (e) for recreational purposes -
 - (i) use the water or the water surface of a water resource to which that person has lawful access; or
 - (ii) portage any boat or canoe on any land adjacent to a watercourse in order to continue boating on that watercourse; and
 - (f) discharge -
 - (i) waste or water containing waste; or
 - (ii) run-off water, including stormwater from any residential, recreational, commercial or industrial site, into a canal, sea outfall or other conduit controlled by another person authorised to undertake the purification, treatment or disposal of waste or water containing waste, subject to the approval of the person controlling the canal, sea outfall or other conduit.
- (2) An entitlement under this Schedule does not override any other law, ordinance, bylaw or regulation, and is subject to any limitation or prohibition there under.

CHAPTER 4 USE OF WATER

As this Act is founded on the principle that National Government has overall responsibility for and authority over water resource management, including the equitable allocation and beneficial use of water in the public interest, a person can only be entitled to use water if the use is permissible under the Act. This Chapter is therefore of central significance to the Act, as it lays the basis for regulating water use. The various types of licensed and unlicensed entitlements to use water are dealt with in detail.

Part 1: General Principles

This Part sets out general principles for regulating water use. Water use is defined broadly, and includes taking and storing water, activities which reduce stream flow, waste discharges and disposals, controlled activities (activities which impact detrimentally on a water resource), altering a watercourse, removing water found underground for certain purposes, and recreation. In general a water use must be licensed unless it is listed in Schedule 1, is an existing lawful use, is permissible under a general authorisation, or if a responsible authority waives the need for a licence. The Minister may limit the amount of water which a responsible authority may allocate. In making regulations the Minister may differentiate between different water resources, classes of water resources and geographical areas.

Water use

21. For the purposes of this Act, water use includes
- (a) taking water from a water resource;
 - (b) storing water;
 - (c) impeding or diverting the flow of water in a watercourse;
 - (d) engaging in a stream flow reduction activity contemplated in section 36;
 - (e) engaging in a controlled activity identified as such in section 37(1) or declared under section 38(1);
 - (f) discharging waste or water containing waste into a water resource through a pipe, canal, sewer, sea outfall or other conduit;
 - (g) disposing of waste in a manner which may detrimentally impact on a water resource;
 - (h) disposing in any manner of water which contains waste from, or which has been heated in, any industrial or power generation process;
 - (i) altering the bed, banks, course or characteristics of a watercourse;
 - (j) removing, discharging or disposing of water found underground if it is necessary for the efficient continuation of an activity or for the safety of people; and
 - (k) using water for recreational purposes.

Permissible water use

- 22(1) A person may only use water
- (a) without a licence
 - (i) if that water use is permissible under Schedule 1;
 - (ii) if that water use is permissible as a continuation of an existing lawful use; or
 - (iii) if that water use is permissible in terms of a general authorisation issued under section 39;
 - (b) if the water use is authorised by a licence under this Act; or
 - (c) if the responsible authority has dispensed with a licence requirement under subsection (3).
- (2) A person who uses water as contemplated in subsection (1)
- (a) must use the water subject to any condition of the relevant authorisation for that use;
 - (b) is subject to any limitation, restriction or prohibition in terms of this Act or any other applicable law;
 - (c) in the case of the discharge or disposal of waste or water containing waste contemplated in section 21(f), (g), (h) or (j), must comply with any applicable waste standards or management practices prescribed under section 26(1)(h) and (i), unless the conditions of the relevant authorisation provide otherwise;
 - (d) may not waste that water; and
 - (e) must return any seepage, run-off or water containing waste which emanates from that use, to the water resource from which the water was taken, unless the responsible authority directs otherwise or the relevant authorisation provides otherwise.
- (3) A responsible authority may dispense with the requirement for a licence for water use if it is satisfied that the purpose of this Act will be met by the grant of a licence, permit or other authorisation under any other law.
- (4) In the interests of co-operative governance, a responsible authority may promote arrangements with other organs of state to combine their respective licence requirements into a single licence requirement.
- (5) A responsible authority may, subject to section 17, authorise the use of water before -
- (a) a national water resource strategy has been established;

Vengablox (Pty) Ltd was appointed by Greenmined Environmental (Pty) Ltd to undertake the Environmental Authorisation (EA) application for the proposed mining of sand from 238.5426 ha that extends over Portion 0 and Portion 1 (Remaining Extent) of the Farm De Klerks Kraal No 231 RD within the Lejweleputswa magisterial District of the Free State Province.

A Draft Scoping Report (DSR) has been submitted in terms of the National Environmental Management Act, 1998 (NEMA Act 107 of 1998) and the National Environmental Management Waste Act, 2008, in respect of listed activities that have been triggered by applications in terms of the Mineral And Petroleum Resources Development Act, 2002 (MPRDA) (As Amended). The proposed mining right footprint is an extension of the existing Blazecor mining permit area (4.8 ha) located within Remaining Extent of Portion 0 of Farm De Klerks Kraal No 231. The mining right footprint will be divided into smaller mining areas of ± 2.5 ha each and they will be rehabilitated prior to the opening of other minor area. 1.5 ha will be used for the operation of the processing plant.

It is noted that a Heritage Impact Assessment (HIA) (inclusive of an archaeological and palaeontological studies) will be conducted for the proposed mining right area. The findings of the specialist studies will be incorporated into the DEIA.

A PIA was conducted by Prof Marion Bamford and the assessment concluded that it is unlikely that fossils would be preserved in the transported sands of the Quaternary and that the impact on the palaeontological heritage would be low.

Interim Comment

The SAHRA Archaeology, Palaeontology, Meteorite (APM) unit notes the HIA and the recommendations provided therein. It is noted that a PIA has been undertaken for the proposed mining, however it has not been attached to the case on SAHRIS. Please submit the PIA report before further comments can be issued.
